Key Points:

- Any designation of your own dependent as a recipient is prohibited.
- Awards will be made without regard to the student's race, color, sex, handicap, familial status, or national origin.
- Visit www.CCSTO.ORG and donate On-line or download a Donation Form and donate by check. Either way, receive a **Dollar-per-Dollar tax credit.**
- Your donation is eligible as a Federal Charitable Contribution.

A.R.S. § 43-1089.03 G states that a contribution that is made on or before April 15th (or Tax Day) following the close of the taxable year may be applied to either the current or preceding taxable year.

The AZ State Income Tax Credit

Arizona allows an individual income tax credit for donations made to STOs that provide scholarships to private schools. The Original individual income tax credit for contributions to school tuition organizations is governed by A.R.S. § 43-1089 and Chapter 16 in Title 43.

Arizona allows a second individual income tax credit for individuals wishing to give more than the amount allowed for an individual income tax credit under the original individual income tax credit program. The Switcher individual income tax credit for contributions to school tuition organizations is governed by A.R.S. § 43-1089.03 and Chapter 16 in Title 43. After donating the maximum original individual income tax credit, individuals can donate additional monies and take this additional credit.

The maximum combined Arizona State income tax credit for **Tax Year 2018** is \$2213 for Married Filing Joint taxpayers and \$1107 for Single taxpayers.

NOTICE: A SCHOOL TUITION ORGANIZATION CANNOT AWARD, RESTRICT OR RESERVE SCHOLARSHIPS SOLELY ON THE BASIS OF A DONOR'S RECOMMENDATION. A TAXPAYER MAY NOT CLAIM A TAX CREDIT IF THE TAXPAYER AGREES TO SWAP DONATIONS WITH ANOTHER TAXPAYER TO BENEFIT EITHER TAXPAYER'S OWN DEPENDENTS.

Cochise Christian School Tuition Organization, Inc.

Cochise Christian School Tuition Organization (CCSTO) is a 501(c)3 nonprofit organization. We became incorporated in 2002. Our purpose is to assist children in receiving an Arizona tuition scholarship to attend the Christian school of their choice. Scholarships are awarded from the contributions of AZ taxpayers who use the AZ Private School tax credit program.

Donate through CCSTO and **receive a dollar-per-dollar tax credit.** Your tax credit donations will be used for tuition scholarships for K-12 students attending Christian schools in Arizona. Your donation is also eligible as a Federal Tax Contribution.

You may use the form to the right or you may visit www.ccsto.org to download a Donation Form or make your donation On-line. You may also split your donation and make multiple payments, if more convenient. A Donation Form must accompany each donation.

The state allows a taxpayer to donate to CCSTO up to April 15th and allows that tax credit to be used for the previous tax year.
